

YELLOWSTONE TIKTOK HASHTAG CHALLENGE OFFICIAL RULES

NO PURCHASE IS NECESSARY TO PARTICIPATE OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

TO BE ELIGIBLE TO PARTICIPATE AND WIN A PRIZE (AS THAT TERM IS DEFINED BELOW), YOU MUST LIVE IN THE UNITED STATES OF AMERICA. YOU MUST ALSO SATISFY THE OTHER ELIGIBILITY REQUIREMENTS SET FORTH BELOW.

WITHOUT LIMITATION, THIS CONTRACT PROVIDES FOR INDEMNIFICATION OF THE SPONSOR, AS DEFINED BELOW, AND OTHER PROMOTION ENTITIES BY YOU, A CLASS ACTION AND JURY TRIAL WAIVER, A REQUIREMENT THAT MOST DISPUTES BE SETTLED BY MANDATORY BINDING ARBITRATION, AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1) Promotion Entry Period: The Promotion begins at approximately 12:00:01 AM Eastern Standard Time (“EST”) on November 11, 2022 and ends at 11:59:59 PM (EST) on November 13, 2022 (the “Promotion Entry Period”). At approximately 10:00:01 AM (EDT) on November 11, 2022, the beginning of the Promotion Entry Period, Sponsor, as defined below, will post a call to action from the @Yellowstone social handles (the “CTA Post”). As soon as the CTA Post is issued, eligible participants may participate in the Promotion as provided herein.

2) Eligibility: To be eligible to receive a Prize, participants must, at the time of entry, meet all of the following requirements: (a) be legal residents of the fifty (50) United States or the District of Columbia (“Territory”); (b) be eighteen (18) years of age or older (provided, however, that if a participant is at least 18 but deemed a minor in their jurisdiction of legal residence, they must have the consent of their parent or legal guardian in order to participate); and (c) be registered users of TikTok with a public profile that is open to receiving direct messages (each, a “Participant(s)”). If you are not already a registered TikTok user, it is free to sign up. Employees, officers, directors and agents of Paramount Global (“Sponsor”) and any other company involved in the presentation, administration or fulfillment of the Promotion, and their respective parent companies, subsidiaries, affiliated companies, and divisions (collectively, the “Promotion Entities”) and each of their immediate family members (defined as any spouse, partner, parent, legal guardian, sibling, child, legal ward, grandparent, or grandchild, regardless of where they reside) and/or those living in the same household of any such person (whether or not related) are not eligible for the Promotion. 4) How To Enter into the Promotion: You must follow Sponsor's @Yellowstone handle on TikTok to participate and receive updates about the Promotion. After the CTA Post is made, during the Promotion Entry Period, participants can enter by posting a public TikTok and posting it to your own TikTok account (the "Participation Post") which must include hashtags "YellowstoneTV and #YellowstoneTVSweepstakes (collectively, the "Required Hashtags") in the caption of the Participation Post (collectively, an "Entry" or a "Participation Action"). Videos must be no longer than sixty (:60) seconds in length and in 9:16 aspect ratio. If you are chosen as the Winner at the end of the Promotion Entry Period (see section 7 "Winner Selection") you will receive a message from Sponsor via DM on I TikTok, with a request for contact information and further instructions on how to complete the verification process to claim the Prize (hereinafter defined). In order to be eligible to win a Prize, you must respond to Sponsor's request by providing your name, mailing address, email address, phone number and a copy of your valid US government-issued photo identification confirming your identity within a twenty-four (24) hour period. Limit one (1) Entry per person permitted. Entries must: (a) be the original work product of Participant; (b) be solely owned by Participant and with no other person or entity having any right or interest in it; and (c) not violate any third-party rights including but not limited to copyright, trademark, patent, contract, and/or publicity or privacy rights, of any other person or entity. Each Participant hereby represents that the content contained within each Participation Post: (i) is not defamatory; (ii) is not sexually explicit or suggestive, does not contain nudity or any dangerous activity or is profane, pornographic or violent; (iii) is not, expressly or impliedly, derogatory of any ethnic, racial, gender, religious, or age group or endorses any form of hate or hate group; (iv) does not promote any particular political agenda or message; (v) does not contain any symbols, clothing or other messages associated with any gang; (vi) does not contain any music or lyrics which have not been composed and written in its entirety by the Participant and is in all other respects the original work of the Participant; (vii) does not contain any third-party materials and visuals including (but not limited to) logos, or brand names, posters, artwork, content appearing on television and video screens; (viii) has not been copied from and does not infringe or breach the rights (including, but not limited to, any intellectual property rights including any copyright or design rights) of any third party; (ix) does not reveal any personal information including, but not limited to, personal names, email addresses, street addresses or license plate numbers; (x) does not show any identifiable individual unless such individual has expressly consented to featuring in such Participation Post (and for such Participation Post to be used in connection with the Promotion); (xi) does not contain any website links; (xii) is not otherwise offensive or illegal in any way or depicts or simulates any activity that is offensive or illegal; and (xiii) is not in violation of these Official Rules. Automated or bulk Entries or Entries submitted by third parties will be disqualified. Entries must be submitted by the Participant. Any attempt by any Participant to obtain more than the stated number of Entries by using multiple and/or different identities, forms, accounts, registrations, email addresses, logins, or any other methods will void that Participant's Entries, and that Participant may be disqualified in Sponsor's sole discretion. Multiple Participants are not permitted to share the same e-mail account. In the event of a dispute as to any Entry, the authorized account holder of the e-mail account provided

with the Entry will be deemed to be the Participant. The “authorized account holder” is the natural person assigned the account by TikTok. Potential Winners may be required to show proof of being the authorized account holder to the Sponsor or will be disqualified. Entries from an invalid, non-working, or inactive account will be disqualified and ineligible to win. Incomplete, illegible, corrupted, or untimely entries are void and will be disqualified.

6) Prize (1): The one (1) Winner will receive cash prize of \$4000 (payable in the form of a company check) and a \$900 gift card to the Yellowstone TV Shop (<https://yellowstonetvshop.com>) (collectively, the “Prize”).

The Prize may not be sold, traded, transferred, refunded, commissioned or redeemed for cash value elements may not be substituted by Winner.

The approximate retail value (the “ARV”) of the Grand Prize is \$4,900.00 and the total ARV of all prizes to be awarded in this Sweepstakes is \$4,900.00. If the Prize is forfeited in its entirety, and there is sufficient time to determine and notify an alternate Winner, the Prize may be awarded to an alternate Winner. Sponsor reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the order process or the operation of the Promotion; violates the Official Rules; is suspected of cheating, fraud, or acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that or any other provision. If, for any reason, the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, changes to the TikTok platforms that are not acceptable to Sponsor, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Promotion, then Sponsor reserves the right in its sole discretion to cancel, modify, suspend or terminate the Promotion in whole or in part.
